- 1. Data Sharing We do not sell your personal data. We may share your information only when necessary to provide our services, for example:
- 2. With event venues or suppliers to coordinate logistics.
- 3. With our professional advisors (accountants, lawyers) if required.
- 4. Data Retention We retain personal data only for as long as necessary for the purposes described:
- 5. Event bookings: Until 7 years after the event (for accounting and legal purposes).
- 6. Marketing data: Until you unsubscribe or withdraw consent.
- 7. Your Rights Under UK GDPR, you have the following rights regarding your personal data:
- 8. Access request a copy of your data we hold.
- 9. Rectification correct inaccurate or incomplete data.
- 10. Erasure request deletion of your data, subject to legal obligations.
- 11. Restriction of processing limit how your data is used.
- 12. Objection object to direct marketing.

- 13. Data portability request a copy of your data in a usable format.
- 14. Withdraw consent for marketing communications, at any time.
